

Privacy Policy

José Artur Martins Matos, owner of the **Fora da Lei wine** brand, is committed to respecting the privacy and confidentiality of the personal data made available to him and therefore in this document you will find information on the way in which they are treated in accordance with the General Regulation of Data Protection. We have adopted administrative and technological measures to comply with the new General Data Protection Regulation.

In what situations do we collect your personal data?

Your personal data will be obtained and processed in the following cases:

If you contact us directly, namely through our website or any other service we provide and if you are interested, for example, in our products and services and/or if you have any questions;

In the case of purchasing products or services directly;

Eventually, if you respond to one of our direct marketing campaigns, for example, by filling in your details on our website, expressly accepting the processing for that purpose.

Cookies

When you visit our website, a small text file (Cookie) is created and written to your computer's disk. This file, when recognized, will allow you to access it more easily and quickly, and personalize the page in terms of your online experience. We also identify technical information about your computer when you visit pages on our website, such as IP (Internet Protocol), operating system, browser type. We use this information to improve the quality of your visit to our website, and will not disclose it to external entities. Most browsers automatically accept these files (Cookies), but you can delete them or automatically block them.

What personal data can be collected?

Contact data: name, address, telephone number and email address;

Consumer preferences;

Other personal data: Information that may be provided regarding your birthday or other information;

Use of websites and communications: Information about how you use the website and whether you opened or forwarded our messages, including data obtained through cookies or other tracking technologies;

Transaction or interaction data: Information about the purchase of products, interaction with customer service, among others.

What is the purpose of collecting personal data?

Personal data is collected from a marketing perspective, with the explicit consent of its holders, thus allowing us to make our products, projects and other useful information known via email, as well as maintaining contact with them over time and as long as it is in the interests of both parties.

Will my data be shared with third parties?

The data may be shared with third parties, namely with infrastructure providers (server/web hosting service and email) or other providers related to services that we may contract, as well as for the execution of the contracted services. In addition, data may be shared with third parties in the case of any specific partnership that we develop with another market operator. In this case, all data holders will be informed in a timely manner, and will be given the possibility to object to this sharing. The data may be shared with judicial, tax and regulatory authorities to comply with legal requirements.

Can this privacy policy change?

Yes, depending on the evolution of legislation and technology, it is possible that the current privacy policy will be changed. All changes will be reflected in this document available online.
